Chairman CHEY Jong-hyon (1929 - 1998)

The late Chairman CHEY Jong-byon was a visionary who transformed SK Group into a global leader in scientific and technological innovation. He was also a pioneering philanthropist who, with a lifelong dream of developing a truly advanced country, established the Korea Foundation for Advanced Studies and nurtured a talent pool of 1,000 Ph.Ds who were later dedicated to Korea's economic, societal and political modernization. His philosophy and vision continue to serve as a guiding principle for the Chey Institute for Advanced Studies' efforts to open a new era of knowledge-sharing for a better future.

Chey Institute for Advanced Studies was established in 2018 to become a global knowledge sharing platform that identifies geopolitical risks and scientific innovation challenges facing the Korean Peninsula and Northeast Asia.

Almost 50 years have passed since my father, the late Chairman CHEY Jong-hyon, established the Korea Foundation for Advanced Studies (KFAS), an institution dedicated to the

education of young Korean scholars. Since the 1970s, Korea has achieved unprecedented economic growth and has now joined the ranks of advanced countries. Much of this can be attributed to Korea's remarkable growth in human capital. The excellence achieved by many Korean scholars in all areas of human advancements has transformed Korea into one of the world's most innovative nations.

Today, the environment surrounding the Korean Peninsula and Northeast Asia has become increasingly challenging and complex. In addition to existing geopolitical challenges, new issues that threaten regional coprosperity and stability have emerged, including the US-China strategic competition, North Korea's rapid advancements in nuclear and missile capabilities, climate changes, and global health crises such as the COVID-19 pandemic.

To wisely tide over these challenges and draw a new blueprint for regional peace and prosperity, we established the Chey Institute for Advanced Studies as a knowledge-sharing platform that identifies the various risks facing the Korean Peninsula and Northeast Asia, and comes up with strategies to overcome such hurdles. Based on the SK Group's long-standing commitment to social good, we actively support the Chey Institute in their mission to become an intellectual hub of Korea and beyond that binds global opinion leaders together and weaves their wisdom and insights into a shared vision for the future.

Carrying on the vision of the late Chairman Chey, the Chey Institute will continue to promote academic exchange, research and innovation as the driving forces of economic, political and social advancements in Korea as well as in Northeast Asia. The Chey Institute for Advanced Studies is a knowledge-sharing platform established in October 2018 to commemorate the 20th anniversary of the passing of Chairman CHEY Jong-hyon, former Chairman of SK Group. The late Chairman had an unswerving dedication to modernizing Korea by means of supporting young Korean scholars. Our Institute was named in honor of the late Chairman Chey.

The Chey Institute separates itself from other traditional think tanks with its commitment to analyzing the impact of scientific innovation on modern society. Specifically, the Chey Institute commits to the following three missions: first, to identify geopolitical risks in Northeast Asia and devise strategies to deal with such risks; second, to explore the opportunities and challenges posed by scientific innovation; and third, to investigate the impact of scientific innovation on geopolitical and geoeconomic dynamics of the region.


To this end, the Chey Institute has collaborated with leading academic institutions and research organizations around the world to deepen and newly formulate extensive and yet inclusive intellectual platforms to ex-

amine these three critical areas. In particular, the Chey Institute has been partnering with globally renowned think tanks such as the Center for Strategic and International Studies (CSIS) and the RAND Corporation to organize high-profile conferences and workshops. The Chey Institute has also co-hosted international forums with prestigious academic institutions in Asia, including Beijing University, Fudan University and the University of Tokyo. In December 2021, the Chey Institute will hold the inaugural 'Trans-Pacific Dialogue,' a milestone nonpartisan dialogue inviting the most influential opinion leaders, scholars, current and former high-ranking officials, and business leaders from the US, Japan and Korea to address the most pressing global challenges of our time. We are going to expand the horizon of this initiative to other major Asian partners including China and the ASEAN countries.

Through continued collaboration with leading thinkers and institutions around the world, the Chey Institute will maintain its commitment to providing knowledge and discourse conducive to the understanding of modern-day risks and to the creation of their solutions.


GEOPOLITICAL RISKS


The years 2019-2020 were highlighted by unprecedented challenges and opportunities that raised uncertainties on the Korean Peninsula and in Northeast Asia. The Chey Institute's focus on geopolitical risks encompasses various topics ranging from traditional security issues such as US-China strategic rivalry and North Korea's nuclear and missile development program to new frontier agendas, including emerging technologies and public health.

Against this backdrop, the Chey Institute has organized public as well as private sessions in 2019-2020 to shed light on how regional stakeholders should respond to such risks. It has also hosted international forums, multilateral dialogues, and special lectures with world-renowned scholars.

In December 2019, the Chey Institute expanded its horizon by successfully launching the Tokyo Forum. The inaugural Tokyo Forum, titled "Shaping the Future," was significant because it provided much needed cooperation and collaboration between Korea and Japan at the track-II level. Furthermore, in December 2020, the Chey Institute launched the Joint Commission on Northeast Asia and the Korean Peninsula with CSIS as its signature project on geopolitical risks in Northeast Asia. Consisting of former senior-level officials from Korea and the United States, the Commission aims to host multiple public as well as private workshops, and produce a joint report on the current status and future of Korea-US relations.








SCIENTIFIC INNOVATION

New developments in science and technology (S&T) have shaped the way humans interact with the world. More recently, we have reached an inflection point where innovation can completely transform existing paradigms.

The Chey Institute seeks to identify current trends and explore future prospects in S&T innovation. This goal requires interdisciplinary collaboration between scientists, engineers, and social scientists as well as knowledge transfer between academia and industry. To this end, we launched the Scientific Innovation Series, an interdisciplinary platform for world-leading experts to collaborate with each other in sharing their expertise in various S&T areas. In 2019-2020, around 30 distinguished scholars participated in the Chey Scientific Innovation Conferences or special lectures on topics such as artificial intelligence (AI), robotics, semiconductor, battery, neuroscience, and bioengineering.

In 2020, amid the flood of misinformation spreading during the COVID-19 pandemic, the Chey Institute recognized the importance of providing the public with accurate information based on scientific evidence and data. The Chey Institute's COVID-19 Webinar Series was launched to provide our audience with a deeper understanding of the epidemiology as well as clinical and immunological characteristics of COVID-19.

The Chey Institute will continue to facilitate the growth of the intellectual community and help the public thrive in this era of unprecedented scientific and technological changes.




SCIENTIFIC INNOVATION & GEOPOLITICAL RISKS

Science and technology are advancing at breakneck speed. While human innovations are nothing new, the speed and scope of their impact on today's world has been truly unprecedented. The advent of technologies such as AI and machine learning has opened new realms of possibilities the likes of which we have never imagined before; mobile and cloud technologies are making lives more convenient and interconnected; robots and uncrewed systems are providing safer and more efficient alternatives to humans in the military context; space is becoming the ultimate new frontier in piquing human curiosity and advancing human interests.

These technologies, however, are proving to be a double-edged sword. Risks associated with these technologies, including misunderstanding, misapplication, and ill-intentioned applications of immature technologies, could exacerbate existing geopolitical tensions in Northeast Asia and beyond. For example, AI introduces new risks as such as decision-making based on biased data and the potential to trigger an AI arms race. By relying on cyberattacks, rogue countries such as North Korea could dampen the impact of economic sanctions by stealing millions of dollars. Also, space technologies could provide a new avenue for countries to upset the regional and global balance of power.

In light of these risks, the Chey Institute is working to provide objective and accurate information to the public and policymakers so that they could better understand the risks that scientific innovation poses to geopolitics.

February 14-15, 2019

Northeast Asia in Transition


On February 14-15, 2019, the Chey Institute held its inaugural conference titled "Northeast Asia in Transition." A total of 35 participants from Korea, the United States, and China joined the in-depth discussions on security, economics, and scientific and technological developments in the Northeast Asian region.

In his welcoming remarks, Chairman CHEY Taewon emphasized the importance of values such as peace, balance, and harmony as more than just academic research topics.

President PARK In-kook stated that the Chey Institute will serve as a compass and powerhouse for generating interactive dialogue during this era of growing uncertainty and unpredictability.

Delivering his congratulatory message, Korean Vice Foreign Minister CHO Hyun expressed optimism that intellectual exchanges and engagement at the track-1.5 level could develop further into institutionalized Korea-US-China trilateral meetings. U.S. Ambassador to Korea Harry HARRIS highlighted the strategic importance of the Korean Peninsula to the U.S. commitment to a free and open Indo-Pacific and encouraged participants to play a proactive role in shaping the regional future.

The first session entitled "A New Cold War at the Crossroads" focused on three inter-related issues: the future of US-China relations, escalation of tensions in Asia due to US-China competition, and new operating systems for the Asia-Pacific region to alleviate US-China tensions. The second session, "Finding a Solution or Freezing the Status Quo," zeroed in on the Korean Peninsula's security issues, including expectations from the Hanoi Summit, the future of the Korea-US alliance, nuclear non-proliferation, and the effectiveness of economic sanctions. In the third session titled "From Trade War to Technology Hegemony," speakers explored the implications of the US-China trade war on the international trade regime. During the fourth session entitled "Towards a New Strategy in the Transition of Northeast Asia," participants focused on three issues: the transition of power in Northeast Asia, the transition from globalization to anti-globalization, and the rise of identity politics in the region. The final session, "Scientific Innovation and its Impact," focused the scientific and technological advancements that will transform the human society.



Increasingly, the role of partners in Japan, Korea, Australia, and across Asia is to remind the Americans the importance of our role and how critical a strong stable predictive America is needed for the stability of Asia region. I urge all of you today to pull us aside and explain to us how important the U.S. role has been and will be in the future.

CHEY-CSIS COMMISSION ON NORTHEAST ASIA AND THE KOREAN PENINSULA

December 2020

On December 2020, the Chey Institute and CSIS launched the Joint Commission on Northeast Asia and the Korean Peninsula to form a collective vision for the future of the Northeast Asian region and the ROK-US alliance. The Commission consisted of a high-level delegation of former government officials and scholars from Korea and the United States.

The Commission undertook its activities with the following underlying themes: the future of US-China relations and its impact on the Korean Peninsula, prospects for North Korean denuclearization and the future of the ROK-US alliance, and the future of multilateral diplomacy in terms of global public goods, including cooperation in emerging new frontier agendas. Since its inception, the Commission has convened two closed workshops and three public sessions.

KOREA-US-CHINA TRILATERAL CONFERENCE

July 11-12, 2019

The Chey Institute launched the Korea-US-China Trilateral Series with the firm belief that in-depth discussions among the three countries are critical for sustainable peace and co-prosperity. The Trilateral Conference has established itself as a leading forum for track-II discussions on multifaceted challenges and opportunities. While the initial Trilateral Conference addressed traditional security issues such as US-China relations and North Korean nuclear proliferation, more recent iterations have expanded onto issues dealing with the impact of scientific innovation on geopolitical risks.

On July 11-12, 2019, the Chey Institute hosted the fourth Korea-US-China Trilateral Conference entitled "Korea at Crossroads: Geopolitical Upheaval and Scientific Innovation." During the first session,

participants focused on the ramifications of technological rivalry for the future US-China relations. In the following session, participants explored questions of whether working-level negotiations between the U.S. and North Korea will eventually lead to North Korean denuclearization and whether trilateral cooperation would be possible amidst the US-China trade war. In the last session, participants addressed the impact of scientific innovation on geopolitical risks in Northeast Asia.

With four iterations underway, the Trilateral Conference has become a valuable platform where opinion leaders from the three countries can exchange candid insights and, in doing so, raise public awareness regarding some of the most pressing issues facing Northeast Asia.

Where is the World Headed?

On August 27, 2019, the Chey Institute invited Prof. Stephen WALT (Harvard University) for a special lecture titled "Where is the World Headed?" In his comprehensive lecture, Prof. Walt predicted that the wealth and power dynamics of nations will not change greatly in the foreseeable future. He added that the US-China competition for hegemony will continue until 2050. He also noted that the Korea-US alliance should remain the lynchpin of Korea's security policy since the two countries have much to gain by continuing their cooperation.



On September 24, 2019, in his special lecture titled "In Search of a Durable Strategy to Guide ROK-US Relations," Dr. John HAMRE (CSIS) discussed the fundamental meaning and importance of the ROK-US alliance. Dr. Hamre assessed that North Korea was not the singular reason for the U.S. forces' presence on the Korean Peninsula, stressing that the role of the ROK-US alliance goes beyond the Korean Peninsula and plays a vital part in regional security. He also noted that regional security in Northeast Asia for the next decades would depend heavily on a unified Korea that protects the values of free market and democracy.

The Biden Administration and North Korea

On November 20, 2020, the Chey Institute hosted a webinar titled "The Biden Administration and North Korea." The session invited experts with hands-on experience in the North Korea denuclearization negotiations and those with extensive research background on the North Korean nuclear issue. Participants discussed how the Biden Administration would approach US-DPRK relations and envisioned what future North Korea nuclear negotiations and diplomatic strategies would look like.


The Realistic Future of Human Life

On July 31-August 1, 2019, the Chey Institute held its inaugural Scientific Innovation Conference entitled "The Realistic Future of Human Life." A total of 16 distinguished scholars shared their invaluable expertise on AI, nanomaterials, bioengineering, neuroscience, and quantum technology. Almost 1,000 audience members attended the two-day conference to better understand the current status and future of science and technology.

The plenary speakers, Prof. Paul ALIVISATOS (UC Berkeley) and Prof. Stephen BOYD (Stanford University) opened the conference by introducing realistic applications of nanomaterials and machine learning theories, respectively. In the first session, "Artificial Intelligence," Prof. Takeo KANADE (Carnegie Mellon University), Prof. ZHANG Byoung-Tak (Seoul National University), and Prof. SEOK Mingoo (Columbia University) discussed developments and prospects of AI technologies. During the second ses-

sion titled "Life Science," Prof. HYEON Taeghwan (Seoul National University), Prof. HA Taekjip (Johns Hopkins University), Prof. LEE Sang Yup (KAIST), and Prof. KIM V. Narry (Seoul National University) discussed the latest developments in biological and bioengineering research.

The second day began with the third session, "Neurosciences," starring Prof. Marvin CHUN (Yale University), Prof. LEE Daeyeol (Johns Hopkins University), LEE Jin Hyung (Stanford University), and CHUNG Kwanghun (MIT). The speakers introduced cutting-edge technologies that advance or create new ways of understanding the human brain. The final session, "Quantum Science and Technology," was joined by Prof. PARK Hongkun (Harvard University), Prof. KIM Philip (Harvard University), and Prof. PARK Jiwoong (University of Chicago), who provided a comprehensive snapshot of the quantum sector.






THE 2ND CHEY SCIENTIFIC INNOVATION CONFERENCE

January 10, 2020

Enabling Future of AI: Battery to Semiconductor



On January 10, 2020, the second Scientific Innovation Conference titled "Enabling Future of AI: Battery to Semiconductor" was held with almost 700 people in attendance. During the conference, ten renowned scholars participated in riveting discussions on AI, batteries, next-generation semiconductors, and autonomous driving.

In his opening remarks, Chairman CHEY Taewon emphasized that the development of AI, batteries, and semiconductors can contribute to the creation of social values. Echoing Chairman Chey's views, President PARK In-kook underlined the significant geopolitical implications of innovation in these areas.

The plenary session featured Prof. Tsu-Jae King LIU (UC Berkeley) and Prof. Gerbrand CEDER (UC Berkeley). Prof. Liu discussed next-generation semiconductors and advanced computing paradigms. Prof. Ceder talked about the development of Lithium-ion batteries and presented an outlook for alternative energy storage technology. The discussion session was co-moderated by Prof. SHIN Changhwan

(Sungkyunkwan University) and Prof. KANG Kisuk (Seoul National University).

The first session, "For the AI, By the AI," opened with Prof. WEI Gu-Yeon (Harvard University), who discussed holistic co-design strategies for the emergence of AI. Prof. YI Kyongsu (Seoul National University) presented recent achievements and future agendas on autonomous driving in complex urban environments. Prof. LEE Kyogu (Seoul National University) introduced his research on AI music algorithms. The discussion session was moderated by Prof. AHN Jung Ho (Seoul National University).

The second session, "Future Battery Technology," kicked off with Prof. CHOI Jang Wook (Seoul National University), who introduced a management system that can monitor real-time battery status by measuring the entropy of battery materials. Prof. KANG Kisuk (Seoul National University) delved into the development of new battery material based on biological energy transduction. The discussion was moderated by Prof. HEYON Taeghwan (Seoul National University).





2020 Geopolitical Risk Outlook: Catastrophe or Breakthrough?

On January 3, 2020, the Chey Institute hosted its fifth *Deep Dive* session to assess the recent political turmoil on and around the Korean Peninsula. More than 50 leading experts attended this closed-door session to discuss topics involving North Korea, ROK-US alliance, US-China strategic competition, and ROK-US-Japan trilateral cooperation. Specific topics included North Korea's growing nuclear and missile capabilities, effectiveness of the sanctions regime against North Korea, US-DPRK nuclear negotiations, Intermediate-Range Nuclear Forces Treaty (INF), ROK-US burden-sharing, role of US forces Korea, and THAAD.

Scientific Innovation and Nuclear Weapons

On August 24, 2020, the Chey Institute hosted its sixth *Deep Dive* session to assess the growing challenges posed by nuclear weapons and the impact of scientific innovation on security in Northeast Asia. The Shanghai Forum is an annual academic conference co-hosted by the Chey Institute and Fudan University since 2005.

The 15th Shanghai Forum took place on December 18, 2020 under the title "Asia's New Journey: The Decade Ahead." The forum, which was held online due to

COVID-19, brought together a wide array of opinion leaders. The opening ceremony was attended by President XU Ningsheng (Fudan University), Chairman CHEY Tae-won (SK Group), Secretary General Paula LEHTOMÄKI (Nordic Council of Ministers), ZHANG Yunling (Chinese Academy of Social Sciences), Prof. Oliver HART (2016 Nobel Laureate in Economics; Harvard University), Prof. WEI Shangjin (Columbia University) and Vice Chairman ZHOU Hanmin (Shanghai Committee of the Chinese People's Political Consultative Conference).

Roundtable sessions at the 2020 Shanghai Forum focused on the following topics: the future of Northeast Asia in the changing world; multilateral trade and sustainable development in the post-pandemic era; East Asian regional cooperation under the condition of global alienation; global finance and optimization of energy structure; global cyberspace strategic stability and the new order in cyberspace; and opportunities and challenges for economic and medical development in Asia in the next decade.

TOKYO FORUM 2019

December 6-8, 2019

Shaping the Future

On December 6-8, 2019, the Chey Institute and the University of Tokyo launched the Tokyo Forum at Yasuda Auditorium, a historic landmark of the University of Tokyo. Under the overarching theme of "Shaping the Future," the inaugural Tokyo Forum aimed to promote future-oriented intellectual dialogue amidst escalating geopolitical uncertainties in Northeast Asia.

The first day featured keynote speeches and dialogues by notable global leaders including Jack MA (Founder, Alibaba Group), Masayoshi SON (CEO, SoftBank), Helen CLARK (Former Prime Minister, New Zealand), and Enrico LETTA (Former Prime Minister, Italy).

One of the special sessions, "Korea-Japan Business Leaders' Dialogue," invited top business leaders from Korea and Japan to discuss the growing diplomatic tensions between the two countries and implications for the regional economy. Economic representatives of both countries shared candid opinions on ways to expand exchanges and cooperation at the private level.

Another special session entitled "Challenges and Opportunities – Shifting Geopolitics in 21st Century Northeast Asia" invited renowned international affairs experts, who provided their insights on major challenges in Northeast Asia including North Korea's nuclear threat and US-China strategic competition.

TOKYO FORUM 2020

December 3-4, 2020

Shaping the Future – Global Commons Stewardship in Anthropocene

The Chey Institute and the University of Tokyo co-hosted the second Tokyo Forum on December 3-4, 2020. Despite being held online due to COVID-19, the Forum attracted more than 1,500 live viewers. The 2020 Tokyo Forum, under the theme of "Global Commons Stewardship in Anthropocene," focused on ways to promote international cooperation while combatting the global environmental crisis.

With global leaders from various sectors joining, the Forum discussed pathways to transform our current dysfunctional economic system into a more sustainable model. Prof. Jeffrey SACHS (Columbia University) urged nations to unite globally and build a coalition for global commons. Another keynote speaker, LEE Hoesung (Chairman, Intergovernmental Panel on Climate Change), warned that the equilibrium between nature and human has been breached and stressed the need for development within environmentally sustainable boundaries.

Christiana FIGUERES, a key figure in the successful conclusion of the historic Paris Agreement, issued a stark warning: "It is only over the next 10 years, from now to 2030, that we can influence what is going to happen. We will be in danger of those tipping points having a domino effect on each other and we will lose total control."

INTERNATIONAL CONFUCIANISM FORUM

November 30-December 1, 2019

Since 2004, the Chey Institute and Renmin University of China (RUC) have co-hosted the International Confucianism Forum, a leading conference for research on Confucianism. Held biennially, the forum invites participants to engage in philosophical debates on how human society can overcome global crises through the lens of Confucianism.

In December 2019, the 14th International Confucianism Forum was held in Qufu, Shandong Province under the overarching theme of "Confucianism and World Peace." SOUTHEAST ASIAN CULTURAL VALUES FORUM

Since its inception in 2005, the annual Southeast Asian Cultural Values Forum hosted by the Chey Institute and the Royal Academy of Cambodia has developed into a leading international conference on Southeast Asian cultural issues.

In 2019, the 15th Southeast Asian Cultural Values Forum was held under the theme of "Challenges of Culture in the Technology Age." Important topics such as "Cultural Role for Peace and Development," "Initiatives and Innovations in Culture," and "Cultural Diversities" were discussed. Around 100 scholars and experts attended the forum, including Secretary of State Sum MAB (Ministry of Culture and Fine Arts of Cambodia).









ASIA RESEARCH CENTER (ARC)

Since 2002, the Chey Institute has established 18 Asia Research Centers (ARC) at leading universities and research institutes in Asia, including the Chinese Academy of Social Sciences, Peking University, Tsinghua University, Fudan University, Renmin University of China, Nankai University, Zhejiang University, National University of Mongolia, Vietnam National University, Hanoi, Royal Academy of Cambodia, National University of Laos, University of Yangon, Myanmar, Chulalongkorn University, and the University of Tehran.

ARCs aim to promote regional development by facilitating academic exchanges among Asian scholars. Specifically, they support local scholars' academic activities such as research, publications, academic conferences, and lectures.

The president of the Chey Institute along with the presidents of respective universities and directors of institutions jointly serve as chairmen of the ARCs. They hold regular board meetings and directors' meetings to share major projects and achievements among the ARCs, and discuss future strategies.

Each ARC specializes and operates in the research field in which the university/research institute has a comparative advantage. Since 2002, the Chey Institute has supported 5,375 academic activities (2,838 research projects, 662 academic conferences, 1,432 publications, and 443 other projects).

INTERNATIONAL SCHOLAR EXCHANGE FELLOWSHIP (ISEF) PROGRAM

The International Scholar Exchange Fellowship (ISEF) program aims to strengthen academic studies in Asia and enhance regional academic exchanges and cooperation by inviting Asian scholars to conduct research in Korea. Since 2000, the Chey Institute has supported almost 1,000 promising scholars across Asian countries. Every year, the ISEF program invites 50 scholars to conduct comprehensive research in Korean universities and research centers for six months or a year. The program provides an opportunity for scholars from various countries to interact with Korean academic institutions and scholars, and promotes mutual understanding through research projects on various topics in social sciences, humanities, energy, information and communication, and life sciences. Through cultural activities and seminars, ISEF scholars are able to improve their understanding of Korea and build lasting academic networks with their Korean counterparts. As of 2020, 664 scholars from China and 935 scholars from other Asian countries, including Mongolia, Vietnam, Thailand, Myanmar, and Cambodia, have participated in the program. 58 Korean universities and 36 research institutes participated as partner research institutions.

On September 26, 2019, the Chey Institute organized a session dedicated to "Northeast Asia amid Geopolitical Risks," which identified geopolitical issues that impact the region's security, including US-China relations, North Korea's nuclear challenge, and ROK-US alliance. Panelists included Amb. Marc KNAPPER (U.S.

Department of State), Dr. Victor CHA (CSIS), General Vincent BROOKS (Former Commander of USFK), Prof. JIA Qingguo (Peking University), and Amb. Joseph YUN (Former U.S. Special Representative for North Korea Policy).

The following year, on September 17, 2020, the Chey Institute hosted another special session entitled "The Next 50 Years." This session was created to explore the following question: will the recent geopolitical upheavals lead to a perpetual and systemic transformation or merely imprint transitory, albeit serious, impact on our society? Panelists included Dr. George FRIED-MAN (Geopolitical Futures), Esko AHO (former Prime Minister of Finland), Amb. Joseph YUN (Former U.S. Special Representative for North Korea Policy), and Prof. KIM Byung-yeon (Seoul National University).

On October 16-17, 2020, the Chey Institute, the East Asia Institute (EAI), and Genron NPO hosted the 8th Korea-Japan Future Dialogue in Seoul, Korea. Under the theme "Korea-Japan Cooperation Amidst Changing Global Order," the conference was held to provide future prospects for the bilateral relationship, which has undergone unprecedented turmoil since 2018. Speakers from both countries agreed that the spectrum of common strategic interests is getting broader amidst a changing global order caused by the pandemic and US-China strategic competition.

Change and Continuities: China US Relations in Transition

On December 23, 2019, the Chey Institute hosted the 38th lecture of its China Lecture Series. Under the theme "Change and Continuities: China-US Relations in Transition," Prof. JIA Qingguo (Peking University) gave a special lecture on the current state of US-China relations and its future direction by examining the historical continuity as well as discontinuity in the US-China bilateral relationship. Prof. JIA concluded that close coordination among American and Chinese scholars, experts, and government officials is key to peace in the long-run.

Race for Supremacy: US-China Competition and Northeast Asia

On August 20, 2019, the Chey Institute held a special lecture to examine the US-China strategic competition from economic and technological viewpoints and assess its impact in Northeast Asia. Prof. Peter PETRI (Brandeis University) stressed the importance of de-escalation and processes for decoupling that is currently underway between the two countries. Dr. David DOLLAR (Brookings Institution) assessed the current US-China trade conflict and its impact on global value chains in manufacturing, noting that there will be serious consequences if the effects of the trade war interact with existing domestic risks.

2020 Global and Asian Economic Outlook

Dr. RHEE Changyong

(International Monetary Fund)

On January 15, 2020, the Chey Institute invited Dr. RHEE Changyong (IMF) for a special lecture titled "2020 Global and Asian Economic Outlook." Dr. Rhee presented an overall view of global economic trends in 2019, which he defined as "synchronized slowdown." While he cautiously predicted a slight economic rebound in 2020, he also mentioned geopolitical uncertainties, prolonged low interest rates, limited trade between the U.S. and China, and stressed economies as key factors to monitor.

October 28, 2020

Opening the Door to Peace: The Opportunities and Limits of Sports

Thomas BACH

(President, International Olympic Committee)

On October 28, 2020, the Chey Institute and the Seoul Peace Prize Cultural Foundation jointly held a special lecture by President Thomas BACH (IOC). In his lecture, President Bach stated that peace can achieved through sports, in particular the Olympic Games. He added that while the IOC and other sports federations can open the door to peace, the decision-making of state actors and their cooperation will largely determine whether peace can be realized. The lecture served as an invaluable reminder of the need for international solidarity especially in an era of growing political tension and nationalism.

The Chey Institute published the CHEY-CSIS special joint report on the *Future of Northeast Asia and the Korea-US Alliance*. The report is the outcome of the academic activities carried out by the CHEY-CSIS Commission on Northeast Asia and the Korean Peninsula over a six-months period.

The report explores the future of the ROK-US alliance and its geopolitical implications for issues such as US-China relations, North Korea's denuclearization, trade and new frontier agendas and multilateral diplomacy.
